April 10, 2020 (Los Angeles, CA) – At the end of February, an otherwise unknown artist named **RMR** (pronounced "Rumor") burst onto the scene, fully masked, with a video for his song "Rascal," taking the internet by storm in a zeitgeist moment. Now signed to Warner Records, **RMR** today unveils his brand-new track and powerful video, "Dealer." **RMR** is the premiere artist on the roster of the multi-faceted record label, CMNTY RCRDS. Helmed by industry power players Phil Lawrence, Malik Rasheed, and Chief Johnson, CMNTY RCRDS is at the cutting edge of marketing and music discovery
